- In case of local travel (up to 30 kms one way) conveyance charges may be given on actual basis with upper ceiling of Rs.4500/- per month.

IMPORTANT INSTRUCTIONS:

- All candidates applying for the above post should have their MBBS, MD/DNB degrees recognised by Medical Council of India (MCI).
- All candidates applying for the above posts must be registered with Medical Council of India or State Medical Council.
- The engagement is purely on temporary basis – for a period of 1 year at the time of initial engagement. Subsequent renewal(s) of term can be for a maximum period of three years at the discretion of management. There will be one month notice period on either side.
- There is no reservation for SC, ST and OBC. All applicants will be treated under UR category.
- The upper age limit is 65 years and no relaxation with respect to age will be given to PH, Ex-Servicemen, SC, ST and OBC candidates.
